

STAMP RENTAL AGREEMENT AND CREDIT CARD AUTHORIZATION FORM

Distinctive Concrete – Boston, Inc. (DCB) rents concrete stamps to qualified Customers at a rate of \$25.00 per stamp. The Rental Period for the stamps is 3 days (72 hours) unless other terms are pre-arranged between DCB and the Customer. The Rental Period begins the day the DCB rental stamps leave DCB premises and ends the day the Customer returns the rented stamps to DCB premises.

THE STAMPS ARE TO BE RETURNED CLEAN AND IN THE CONDITION THE CUSTOMER RECEIVED THEM.

THE CUSTOMER IS RESPONSIBLE FOR FULL REPLACEMENT COST OF ANY DAMAGED OR STOLEN STAMPS.

RENTAL FEES ARE CALCULATED FROM THE TIME THE STAMPS LEAVE DISTINCTIVE CONCRETE PREMISES, UNTIL THE TIME THE CUSTOMER RETURNS THEM TO DCB PREMISES. IF THE STAMPS ARE RETURNED LATER THAN 3 DAYS (72 HOURS) THE CUSTOMER AUTOMATICALLY ENTERS INTO ANOTHER RENTAL PERIOD. THE CUSTOMER'S CREDIT CARD WILL BE AUTOMATICALLY CHARGED FOR EVERY ADDITIONAL RENTAL PERIOD CALCULATED FROM THE TIME THE STAMPS LEFT DCB PREMISES.

IF THE STAMPS ARE RETURNED ON TIME BUT IN A DIRTY CONDITION, THE CUSTOMERS CREDIT CARD WILL AUTOMATICALLY BE CHARGED A CLEANING FEE OF \$150.00.

BY SIGNING BELOW, I THE CUSTOMER RENTING THE STAMPS FROM DCB ACKNOWLEDGE AND ACCEPT THESE TERMS AND AUTHORIZE DCB TO CHARGE MY CREDIT CARD PER THE TERMS EXPLAINED ABOVE.
